DUES STRUCTURE:

When joining the ACEC of Nevada, your firm will also be joining as a member of the American Council of Engineering Companies and will receive the benefits of this dual membership. ***(If you are a branch office of a national firm, your national office may already be a member of the American Council of Engineering Companies. In this case you pay only state dues.)***

Dues are based on the estimated number of full-time employees (i.e. engineers, designers, clerical, administration - everyone) in your Nevada office(s). The number of employees is converted to an index number which is used for dues calculations - see table below. **approximate index number rounded to nearest tenth is used to estimate dues only - exact dues will vary slightly.*

2019 - 2020 YEARLY DUES SCHEDULE

ACEC of Nevada (State) dues are \$415 multiplied by your companies' Index Number (Single Employee Firm dues is \$415/year) **Plus ACEC** (National) dues of \$393.12 multiplied by your companies' Index Number (Single Employee Firm dues is \$507/year)

To calculate your firm dues for the fiscal year (June to May), take your estimated index number and multiply it by the ACEC of Nevada dues and then take your estimated index number and multiply it by the ACEC dues and add the two together. If you join mid-year your dues are prorated.

Example:

Firm with 7 employees: Index # 3.04 x ACEC of Nevada Dues (\$415) = \$1262 + Index # 3.04 x ACEC Dues (\$393.12) = \$1195
Yearly Dues \$2457 estimated

For single employee firms the yearly ACEC of Nevada Dues is \$415 and ACEC National dues is \$507. Dues are billed quarterly.
