**Group Registration Discount:** A group registration discount is available for ACEC members registering as Full Attendees: register two and get the 3rd 20% off. To receive the discount, all attendees must be registered in one session using Group Registration.

**Reimbursement from ACEC Business Insurance Trust:** The ACEC Business Insurance Trust is offering a registration reimbursement for one member of a firm who is a member of the ACEC BIT for the ACEC Annual Convention. For Full Attendees only. Limited to one per firm. A reimbursement form will be sent out to attendees after the Convention. Attendance is mandatory for reimbursement.

**First Time Attendee:** A special discount exists for ACEC members who are attending their first Annual Convention.
